## **PRESS RELEASE**

**Agartala, 01.10.2018:**

TNGCL is a Joint Venture of GAIL (India) Ltd, Govt. of Tripura & Govt. of Assam and registered under the Companies Act, 1956 as Limited Company. TNGCL supplies Piped Natural Gas (PNG) in and around city of Agartala and currently serves 36000 + Domestic, 450+ Commercial & Small Industrial Consumers across city of Agartala. TNGCL operates 6 CNG stations and currently dispenses CNG to over 15000 vehicles every day. Two CNG Stations have been commissioned in the month of August 2018 at IOCL's Retail Outlets at Bishalgarh & Bisramganj and commercial operation will start as soon as approval from PESO is received.

In accordance with the Para 8 of the "New Domestic Natural Gas Pricing Guidelines, 2014" issued by Ministry of Petroleum & Natural Gas, PPAC vide its letter dated September 28, 2018 to ONGC, OIL and DGH has notified the revised gas price to be applicable from 1<sup>st</sup> October, 2018 to 31<sup>st</sup> March 2019 as **US \$ 3.36/MMBTU** on Gross Calorific Value Basis. Earlier price of the same was **US \$ 3.06/MMBTU** on Gross Calorific Value Basis. Also, the tariffs for GAIL's Agartala Regional Natural Gas Pipeline has been increased to Rs 45.89 per MMBTU from Rs 5.80 per MMBTU and for the Dukli Maharajganj Natural Gas Pipeline to Rs 46.37 per MMBTU from Rs 6.13 per MMBTU upon implementation of tariff Order No. **TO/06/2018 & TO/04/2018** dated 27<sup>th</sup> September, 2018 (Tariff Order can be downloaded from the link - <http://www.pngrb.gov.in/trans-tariff.html>) as notified by Petroleum and Natural Gas Regulatory Board.

Accordingly the price of PNG and CNG are revised as follows.

The above increase in PNG Prices will be effective from 1<sup>st</sup> October 2018 and for CNG it will be effective from the midnight of 1<sup>st</sup> Oct'2018. The above price would be in force till any further notification.
